Since its founding in 1983, The Marquette Manor Foundation has provided more than \$4 million to support residents who have outlived their financial resources and more than \$600,000 to special projects like renovations to the Health Care Center courtyard adjacent to the Bernard L. Strange Pavilion and the purchase of a new bus to transport residents off campus.

To date, recognition includes the Bernard L. Strange Pavilion, the Lynne O'Day Clinic, the Hubert Strange Board Room, and the Bernice Davy Courtyard. The most recently named recognitions include the Hackl Legacy Dining Room and the Margaret Winkler Activity Room in the Pavilion.



Donor Recognition Naming Opportunities

Opportunities for recognition through named spaces begin with investment levels of \$25,000, with rare opportunity for spaces at \$1 million or more. The majority of opportunities are at the \$100,000 to \$300,000 gift level. The following table highlights some of the prominent places and spaces that have not yet been reserved.
